Item #3 Review Galveston County Pet Registration Proposal

Ms. Beckham discussed the Pet Registration Proposal with the Advisory Committee and outlined the proposed changes that would include moving from an annual licensing fee to a lifetime licensing fee. The proposal also included the pros and cons of Lifetime versus Annual Pet Licenses. Cities were polled and asked if they would support a lifetime license, as well as which cities were currently collecting pet licensing fees and if those cities would consider allowing GCARC to collect and retain pet licensing fees. Ms. Barroso stated that if the proposed changes to the pet registration process were approved by the Committee that the Animal Services Policy would also need to be modified, which would require the 3 step policy approval process involving the UBoH, public and participating cities. Committee Members agreed to take the proposed changes back to their municipalities for feedback. Municipalities agreed to use their events, municipal channels, city websites, newsletters and water bills to advertise awareness about getting pets licensed.
